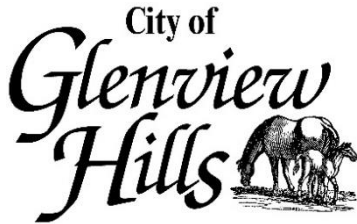

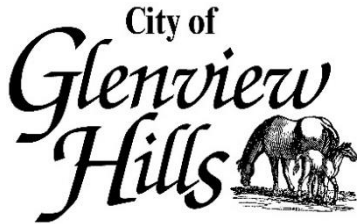

2 (TWO) EXISTING ENTRANCE COLUMNS TO REMAIN INTACT AND BE VENERED WITH DRY STACK LIMESTONE. LIMESTONE TO MATCH GLEN HILL ROAD ENTRANCE (A) AS SELECTED BY CLIENT. CAPITAL TO BE REMOVED AND REPLACED WITH NEW LIMESTONE CAPITAL OF SAME DESIGN AND SPECIFICATION OF ENTRANCE AT GLEN HILL ROAD (A). BRONZE PLAQUES TO BE REMOVED, PRESERVED, AND RE-SURFACE MOUNTED TO THE LIMESTONE VENEER. ALL WASTE AND MATERIAL TO BE HAULED OFF SITE AND INCLUDED IN LUMP SUM PRICE FOR ENTRANCE (B). SITE MUST BE SECURED AT ALL TIMES DURING DEMOLITION AND CONSTRUCTION.
